  NIT on or before the time and date as scheduled and specified given in NIT. The Tender in sealed
  covers/envelope should be addressed to the Director, BP.No.03, Management Office, Vat Phou World
  Heritage Site, Champasak, Lao PDR;
- LAO PDR with the name of the work and due date super scribed on the envelope. The last date for receiving quotation/ Tender is up to 09.00 hours of 25/03/2020 and will be opened in his office on the same day at 10.00 hours;
- 3. The time allotted for carrying out/completion of the works/Supplying materials is up to 15<sup>th</sup> April 2020 from the date of issuing of written order; and may be extendable.
- 4. The Contractor/Supplier should quote his rate inclusive of every demand in words and figures per unit, any corrections in the rates should be attested by the dated signature of the Contractor/Supplier. Otherwise such quotations are liable for rejection. The amount for each item should be worked out and requisite of total should be given;
- 5. The Quotations will be opened at the prescribed time and the date in the presence of bidders who will be present at the time;
- 6. The supply of materials/execution of the works must be completed in all respects to the entire satisfaction of the ASI Technical Team or any officer authorized by him within the stipulated time and no extension of time will be given without any sufficient reason;
- 7. The supply of materials/execution of work must be strictly in accordance with the specifications given in the notice inviting quotations, such materials/works which does not confirm the specification in part or in whole will be rejected. The contractor shall not sublet the contract. All the rates including all taxes shall be quoted in the proper form of the quotation alone. The prices quoted should be firm till the supplies are completed. Rates quoted should be free delivery at destination including all charges. All supplies are subject to inspection and approval before acceptance. Complete details and specifications if any, must accompany the quotation.
- 8. Payment of Tax is primarily the responsibility of the seller/bidder and will not be paid unless the percentage value is clearly mentioned in the quotation. If indication regarding Tax is not recorded in the quotation, the Tax will be considered as included;
- 9. Local Purchase Committee reserved the right to amend or withdraw any of the terms and conditions contained in the NIT or to reject any or all quotations without giving any notice or assigning any reason. The decision of the Local Purchase Committee, in this regard shall be final and binding on all parties in all circumstances:

- 10. Quotations which do not fulfill any of the all conditions or incomplete or conditional quotations in any respect are liable for summarily rejection;
- 11. Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection;
- 12. That contractor has not been debarred by any Government;
- 13. The Quotation bid will be valid up to May 2020 and may be extendable;
- 14. In the Course of executing works/ supply of materials, no damage should be caused to any part of the monument/structure and any such damage on account of the negligence of the Supplier/Contractor shall be responsible for making good the damages at his own cost. The contractor to whom the work is awarded shall ensure that no edifice, protected monument or any part of the protected monument is destroyed or injured during the execution of work or transport the material or by the labour employed by the contractor for the execution of work.
- 15. Since it is a part of the conservation work to the World Heritage protected ancient monuments and not modern works like new works, it is understood that the bidder has inspected the site and assessed the volume and nature of work before bidding for the project; no claim whatsoever will be entertained at any stage, in this regard.
- 16. The agency has to bear with abrupt repeal of funds by the Government and has to wait till fresh allotments are made. No interest payment for the delay in payment will be made by the ASI. The quantum of work can be modified as per availability of the funds and need of the work.
- 17. I/ We am/are well aware of the fact that furnishing of any false information / fabricated document would lead to rejection of my tender at any stage besides liabilities towards prosecution under appropriate law. The information/ document furnished along with the above application are true and authentic to the best of my knowledge and belief. My agency/registration/contract licenses has not been black listed/ debarred from participating in tender of any Ministry/ Department of Government of Lao PDR undertaking in the last three (3) years as on date of opening of this tender.
- 18. I / We certify that all information furnished by the our Firm is true & correct in the event that the information is found to be incorrect / untrue or found violated, then your department /organization shall without giving any notice or reason therefore can summarily reject the bid or terminate the contract, without prejudice to any other rights or remedy including the forfeiture of the full said earnest money deposit absolutely;
- 19. Award Criteria: Employer shall award the Contract to the Bidder whose Bid has been determined to be substantially responsive to the Bidding Document and has offered the lowest evaluated Bid, provided that the Bidder has likewise been determined to be qualified to perform the Contract satisfactorily.

- 20. If any dispute or difference shall arise including this contract, the settlement of which is not herein fore provided for the same shall be referred to the arbitration of the Embassy of India, Vientiane, or if he is unable or unwilling to act as arbitrator to the arbitration of any person nominated by him in writing and the decision of such arbitrator shall be final and binding on the parties to this contract. All the disputes will be settled according to the Government of India's Rules and Regulations and not according to local laws of the Lao PDR; That the contractor shall further keep the Embassy of India ,Vientiane indemnified against any loss to the Embassy of India, Vientiane property and assets. The Embassy of India Vientiane shall have further right to adjust and/or deduct any of the amounts as aforesaid from the payments due to the contractor under this contract;
- 21. The tender and award of contract will be cancelled at any stage during the procurement process or during the execution of resultant contracts, if bidder indulge in the following prohibited activities:
  - a). "Corrupt Practice"- making offers, solicitation or acceptance of bribe, reward of gifts;
  - b). "Fraudulent Practice"- any omission or misrepresentation that may mislead or attempt to mislead so that financial benefits may be obtained;
  - c). "Anti-competitive Practice"- any collusion, bid rigging or anticompetitive arrangement between two or more bidders, that may impair the transparency, fairings;
  - d). "coercive practice"- harming or threatening to harm, persons or their property to influences their participation;
  - e). "conflict of interest"- participation by a bidding firm or any of its affiliates that are either involved or that are part of more than one bid in the procurement;
  - f). "obstructive practice"- materially impede the procuring entity's investigation into allegations of any or more of the abovementioned prohibited practices either by deliberatively destroying falsifying, altering or by concealing of evidence or making false statement to investigations or by threatening, harassing or intimidating any party to present it from disclosing.
